- Promoted from Deputy Director to Principal Senior Deputy Director, D.C.'s 2nd-highest public health official.
- Developed and executed COVID-19 Vaccination Program for the District of Columbia that led to D.C. being the top 15 states in population vaccination coverage by May 2021.
- Decreased senior disparity in COVID-19 vaccine coverage from 2.2x to 1.3x between the richest and poorest zip codes by implementing a zip code-based distributions strategy and including community health centers and houses of worship as distribution sites.
- Created a breast cancer mortality disparity study that identified subtle reasons for mortality disparities among geographic areas and led to changes in patient navigation and care coordination strategies.
- Enhanced prenatal clinical care experience at multiple healthcare sites by onboarding 2 virtual healthcare solutions that is expected to reduce maternal morbidity.
- Developed and implemented strategies to reduce food insecurity in communities.

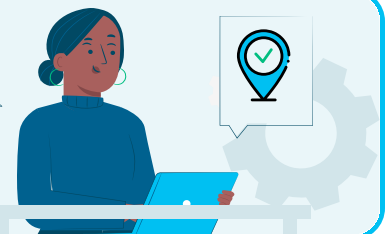
